

### ABOUT OUR NEVADA

Our Nevada is a monthly joint publication between the City of Nevada, Nevada Community School District, Story County Medical Center, Story County, NEDC, and Main Street Nevada.





Mid-States Companies, located and headquartered in Nevada, lowa, is in the final stages of its most recent expansion effort: A 9,000-square-foot administrative office building that is intended to bring together their range of businesses and services under one roof. The expansion is the latest in a long line of reinvestment projects for the company.

Kevin Vier, President and Chief Executive Officer of Mid-States Companies, is a Nevada native and grew up in a family-owned construction business with his father. Through V&H Construction, he had his first opportunity to sell a grain bin dryer. "At the time, I wanted the opportunity to work on larger projects," said Vier, thinking back to the origins of Mid-States.

In 2001, he founded Mid-States Millwrights & Builders (MMB) after working for and eventually purchasing Lint Millwright in Nevada. Over the next two decades, Mid-States expanded from five employees and a 50x70 shop, to a company that now employs over 80 people and includes millwright services, structural steel fabrication, material handling equipment, cranes and trucking services, as well as engineering and design services, as well as engineering and design services. Today, both of his sons, Austin and Riley, are helping to lead the company, Austin as Chief Operating Officer and Riley as Vice President of Marketing & Development.

"Our business has been fortunate to scale in steps," said Riley, acknowledging the history of the company that he grew up in. Since 2001, Mid-States Companies has grown in scope and now occupies over 139,000 square feet of manufacturing space in Nevada.

### In the mid-2000s,

the supply chain of procuring equipment slowed with the ethanol boom. "Since we couldn't get equipment in a timely manner," Vier said, "we realized that we might as well start manufacturing our own equipment. This was when we first started making our own catwalk, towers, platforms, structural steel and soon after, our lines of material handling equipment."

In 2010, they built a 14,000-squarefoot manufacturing facility and officially launched Mid-States Material Handling and Fabrication. The company supported the millwright division by providing structures and material handling equipment.

In the years that followed, the expansions continued to keep up with the demand. A 34,000 square-foot addition was announced in 2017, followed by a 40,000-square-foot addition to the facility as new product lines were developed and additional demand grew. By 2021, the company had built up a fleet of cranes and trucks that were used for MMB projects and launched Mid-States Crane and Trucking to provide those services to external customers. Finally, in May of this year, Mid-States started Mid-States Design

> > & Engineering and brought professional engineering services in-house and created a space for all their existing drafting and design staff to be under one roof.

> > "We are now vertically integrated from design and engineering, to manufacturing, to millwright services, to crane and trucking," said Vier. "We are a one-stop shop for our clients, which is notable as we have more control over the services and products we provide."

> > Mid-States Companies is an economic development success story that reinforces the importance of supporting local expansion projects and how that can positively impact a community. They operate nationwide across 34 states from California to New York. In addition to their own employees, they manage the same number across project sites.

> > "At Mid-States Companies, it's all about the people," said Vier. "We have been blessed with not only family, but also great leaders and dedicated employees across our various operations. It's great to be able to grow this company in Nevada where I and the rest of my family grew up."


# Nevada FFA working to restore prairie at Hickory Grove Park

Story County Conservation (SCC) would like to thank the Nevada FFA Chapter

for its involvement this planting season, as FFA members planted and will harvest 11 acres of soybeans at Hickory Grove Park through a prairie restoration project.

During the lake renovation in 2019, sediments removed from the lake bottom were deposited to a spoil site near Oriole

Ridge Lodge for future prairie establish-



and those grew into a blanket of Canada thistle, smooth brome, and reed canary grass. Planting a prairie into this seed bank was futile, and it was decided the best option was to create a blank canvas by terminating all vegetation and then replanting prairie.

SCC enlisted the help of Nevada FFA, creating a

valuable partnership for both students

and SCC's prairie goals. FFA advisor Kevin Cooper and students spent many hours removing debris from the uneven soil to ensure it wouldn't be a problem for farm equipment. Steve, Jim, and Owen Wilson prepared the soil and planted 11 acres of soybeans, donated by Kolln Seed Sales—Pioneer Seed. This valuable, low-stakes learning experience provided Nevada FFA members a lesson in both agriculture and conservation.

Nevada FFA plans to farm the site again next year and then SCC will have a new prairie seeding the following dormant season. Thank you, Nevada FFA!

# Volunteer works on big project

Denny Thompson is about to get to his favorite part of any construction project.

After around 700 volunteer hours put in working on the upstairs apartments in the Camelot Theater building, Denny said the "finish work" is about to begin.

"Cabinets, trim, doors, floor coverings, mechanicals," he said. "The structures are done. Now it's time to make them pretty."

Denny's volunteer spirit and construction background have been a godsend to the Camelot Theater Foundation, a board he now sits on, as does his wife, Nancy.

"I've never been much of a board/meeting person," Denny admitted, "but it (working with the board and the apartments project) keeps me busy and keeps my mind active. I've also enjoyed the people."

Denny's wife has served on the Foundation board longer than her husband, and it was her involvement that linked him to the theater.

"The theater men's bathroom had a toilet sitting with no floor underneath. It was basically just a stand pipe, and they were getting ready to have their first event. So, Nancy asked if I could go in and help John Beals with the bathroom work. That's how it started," Denny said.

From there, Denny volunteered for more, which has found him being the main person involved in reframing and working on both apartments, one on the second floor and the other on the third.

The biggest challenge with the work, he said, is the age of the theater. "It's an old building. The main structure of the building is really sound, very good. But, some of these upstairs spaces were left unattended for a lot of years, leaving a lot of rot and windows that were rotting."

So, there was ample amount of demo work, then reframing the one-bedroom apartments. Denny is excited to make them both into livable spaces, and he hopes that if all the sub-contractors can be scheduled in a timely manner, most of the work on finishing may be completed yet this fall.

"The best thing about these apartments is location," he said. "My wife and I actually watched the July 4th fireworks from one of the third-floor windows, and we had a nice light breeze and a beautiful view."

Redoing the steps that lead to the apartments was a neces-

sary project and one that was recently completed. Denny needed someone to help on this project and brought in Chad Ullmann of Ullmann Construction. "Chad is new to the community," and was looking, Denny said, for a way to volunteer. Chad has helped with the stairs and a few other parts of the project since joining forces with Denny.

Denny, Chad and some of the other subcontractors have given volunteer time, especially in labor, even though some things, like materials needed, have been paid to them. But Denny has spent, by far, the most volunteer time on this project.

Sometimes, he admitted, he thinks about all the time he's committed and all the other things he should be doing, but he doesn't regret the hours. "It's like every house I've been involved with building. There's a little bit of pride because you're leaving something to the future. I'm going to always come back (to the theater) and remember this place."

For now, he'll keep plugging away at the work that still needs to be done, and he'll continue his service on the Foundation Board, helping wherever needed as the theater portion of the building is eventually renovated.

"I don't ever want to slow down. I was a hyperactive child, and if I slow down, I might not ever get back up."

# **REYNOLDS AWARDED**

Nevada Fire Chief Ray Reynolds re-

ceived the 2024 Excellence in Fire and Life Safety Award at the International Association of Fire Chiefs Fire-Rescue International Conference & Expo, held in Dallas, Texas in August.



The award honors fire and life safety professionals for their leadership, service, and support of model fire codes and standards.

Following two fatal fires in the City of Nevada in 2022 and 2023, Reynolds identified a disturbing upward trend in community and firefighter risk from fires caused by people smoking while using supplemental oxygen in their homes. In the 2022 fire, a 74-year-old woman was pulled from her home alive with severe burns but succumbed to her injuries the next day. The 2023 fire claimed the life of a 73-year-old male and severely burned two family members. Cigarette smoking and home oxygen concentrators were factors in both fires. These tragic incidents spurred Reynolds to organize and lead a national initiative to reduce the risks of fires involving home oxygen therapy and oxygen concentrators.

Modeling a successful approach previously implemented by the Department of Veterans Affairs, Reynolds began advocating for the use of thermal fuses, otherwise known as fire breaks, in oxygen tubing both at the oxygen concentrator and near the patient to help stem the rash of home oxygen fires in the City of Nevada and throughout lowa. Reynolds' efforts were central in convincing lowa's Department of Health and Human Services to publish and distribute information on thermal fuses to Medicaid patients and home medical equipment suppliers.

As a member of the IAFC Fire and Life Safety Section Board of Directors, Reynolds has elevated advocacy for using thermal fuses with oxygen tubing with the nation's fire service. He has delivered presentations to fire and life safety educators, regulators, and federal policymakers with the Centers for Medicare and Medicaid Services in Washington, DC. Additionally, Reynolds served as a member of the International Code Council's Fire Code Action Committee from 2017-2023 where he developed code proposals that enhanced the fire and life safety requirements of the International Codes.

The City congratulates Reynolds on this prestigious honor.

He started as a water and wastewater superintendent in Roland, moving his way up to public works director. While on the job in Roland, he earned his Grade II water treatment license, his Grade II water distribution license, and his Grade II wastewater treatment license. 

On Aug. 27, two Nevada City Streets Department employees helped a group of Leadership Nevada students celebrate the installation of a new "flashing pedestrian sign" at the curve where W 3rd Street meets West I Avenue (by the old Billy Sunday baseball field location).

Leadership Nevada, a program facilitated by Main Street Nevada, IA, divides students into small groups to develop projects that benefit the community. The community betterment project is part of the "course work" for the Leadership program.

# Introducing our School Resource **Officer, Lane VanderHart**

Nevada Police Officer Lane VanderHart is the newest School Resource Officer in the Nevada School District. This position has been brought back to the district following community concerns about school safety in the aftermath of last year's Perry school shooting.

School and City officials worked together to make the position a reality once again. The last SRO in the district was officer Matt Snyder, who served nearly a decade ago.

VanderHart has been with the Nevada Public Safety Department since April of

2022. He is a 2014 graduate of Knoxville High School. His wife Olivia is a park ranger in Story County.

Public Safety Director and Police Chief Chris Brandes said he picked VanderHart for the SRO position because of his calm demeanor and his ability to look beyond just "enforcement" to apply policing in the most effective manner with youth. "He's very relatable and went to a school that had an SRO, so he's seen the position first-hand," Brandes said.

VanderHart's main responsibilities will be to increase school safety, to be a liaison



between students and the police department, and to be a dependable presence at the school on a daily basis, which should enhance the safety of all students and employees.

Superintendent of Schools Dr. Steve Gray said, "NCSD has had a strong partnership with the City of Nevada for many years and that has very much included the support of our local law enforcement agencies, both City and County. Having an SRO will only enhance that communication and collaboration."

# A Note from the Nurse: When is sick too sick for school?

A regular attendance routine is important for your child's well-being and learning. These tips can help you decide when to keep your child home if they don't feel well. If you are unsure if you should send your student to school, you can always call and talk to the school nurse.

### SEND ME TO SCHOOL IF...

- I have a runny nose or just a little cough, but no other symptoms
- I have not had a fever overnight and have not taken fever reducing medicine during that time
- I have a mild stomach ache
- I haven't thrown up overnight and can drink liquids without throwing up
- I have a mild rash and no other symptoms
- I have eye drainage without fever, eye pain or eyelid redness

### **KEEP ME AT HOME IF...**

- I have a temperature higher than 100.4
- I have thrown up two or more times in the past 24 hours
- My stool is watery and I may not make it to the bathroom in time

### SEEK MEDICAL CARE IF...

- I have a temperature higher than 100.4 and any of the following: ear pain, sore throat, rash, stomachache, headache, or tooth pain
- I have stomach pain and fever, bloody or black stool, or am dehydrated, and/or I have not urinated in the last 8 hours
- I have a persistant cough or trouble breathing, or have a fever with the cough
- I have eye swelling, eye pain, or an eye injury
- I have a rash that has blisters, is draining, is painful, looks like bruises, and/or I have a fever with the rash
